

## **Blackpool Magic Convention, terms And Conditions**

### **1. Conditions of attendance.**

- 1.1 By proceeding with the purchase of a registration or theatre ticket you are agreeing to be bound by Blackpool Magicians Club Ltd, Terms & Conditions.
- 1.2. Anyone attending a show or the Blackpool Magic Convention, on a day registration or a full registration under the age of 16 must be accompanied by an adult with a valid registration and or theatre ticket .
- 1.3. Theatre ticket only holders, will be allowed access to the venue one hour before the times and dates stated on the tickets, and will not be allowed back into the any part of the venue once the show has finished.
- 1.4. You must have a valid theatre ticket for access to the the theatre, this includes one day registrants and full registrants
- 1.5. Any one holding a valid registration pass will be allowed back into the venue after the shows to attend any further events.
- 1.6. You must provide proof of identification if asked to do so by an Official of Blackpool Magicians Club Ltd or an official of the venue, failure to do so may result in you being removed from the venue.
- 1.7. Blackpool Magicians Club Ltd reserve the right to refuse admission at any time without prior notice.
- 1.8. Blackpool Magicians Club Ltd accept no responsibility for loss or damage of personal belongings at any time during or after the convention

### **2. Registration and theatre ticket pricing.**

- 2.1. All registration and theatre ticket prices are as shown at time of purchase and are non- negotiable.
- 2.2. All registrations and theatre tickets are non-refundable after 1st November 2017.
- 2.3. Blackpool Magicians Club Ltd accepts no responsibility for lost or stolen registrations and or theatre tickets.
- 2.4. Lost or stolen registrations and theatre tickets may be replaced, at the discretion of Blackpool Magicians Club Ltd Registration Officers. Proof of purchase along with appropriate proof of identity will be required and a charge may be incurred.

### **3. Sale and transfer of registrations and theatre tickets to a third party.**

- 3.1. Theater tickets, may be transferred or sold to a third party, without prior consent of Blackpool Magicians Club Ltd.
- 3.2. Blackpool Magicians Club Ltd, accepts no responsibility or liability, for mis-selling and or mis-representation of theater tickets and or registrations to a third party.
- 3.4. Registrations may be sold or transferred to a third party on condition that Blackpool Magicians Club Ltd are informed, no less than seven days prior to the date of the event, of any sale or transfer of registrations. Failure to do so may result in the cancellation of the registration, no refund will be given.
- 3.5. If a registration is sold or transferred to a third party, Blackpool Magicians Club Ltd must be informed of the full name and address and where possible a valid email address and telephone number, along with appropriate proof of identity of the third party, no less than seven days before the event, failure to do so may result in the cancellation of the registration, no refund will be given.

3.6. Transfer of registrations is strictly forbidden within six days of the event, doing so may result in the cancellation of the registration, no refund will be given.

#### **4. Code of conduct within the venue**

4.1. Registrants must display a valid registration pass with their own name on it at all times whilst in any part of the venue.

4.2. Disruptive or abusive behavior of any kind will not be tolerated. Anyone found behaving in a disruptive or abusive manner may have their registration pass confiscated and be excluded from the remainder of the event, and no refund will be given.

4.5. Anyone engaged in any form of illegal activity within the venue will have their registration pass confiscated and will be excluded from the remainder of the event and may result in exclusion from any future events, no refund will be given.

4.6. Sale of any items within the venue, unless you are a registered dealer, is strictly forbidden, anyone doing so will have their registration pass confiscated and may be excluded from the remainder of the event, no refund will be given

4.7. Handing out of any form of promotional material is strictly forbidden unless prior consent has been granted by a member of Blackpool Magicians Club Ltd Committee. Anyone found doing so may have their registration pass confiscated and be excluded from the remainder of the event, no refund will be given.

4.8. Whilst unauthorized video, sound recording and or photography is permitted in certain areas and at certain times within the venue it must not disrupt the running of the Blackpool Magic Convention in any way (see 4.2)

#### **5. Lectures**

5.1. Blackpool Magicians Club Ltd reserves the right to change any part of the advertised programme of events, without prior notice.

5.2. Anyone who is found to be behaving in a disruptive manner during a lecture will be asked to leave the lecture (see 4.2)

5.3. All mobile devices must be switched off during lectures, anyone found using any kind of mobile device in any way during a lecture will be asked to leave.

5.4 Any form of unauthorized video or sound recording and or photography is strictly forbidden in any part of any room that has a lecture in progress, anyone found doing so will be asked to leave and may have their registration pass confiscated and be excluded from the remainder of the event, no refund will be given.

#### **6 Dealers Halls**

6.1 Any video or sound recording and or photography of any kind that involves dealer stands or dealers products, must be with the express permission of the individual dealers involved it is the duty of the person or persons involved in any such activity to acquire permission from the relevant dealers. Any person failing to do so, may have their registration pass confiscated and be excluded from the remainder of the event, no refund will be given.

6.2. Dealers halls will close at 5.30pm, unless otherwise stated, registrants must exit the dealers halls immediately when asked to do so by an official of Blackpool Magicians Club Ltd or an official of the venue, failure to do so may be considered disruptive behavior (see 4.2)

#### **7. Shows and performance areas.**

7.1. All mobile devices must be switched off while you are in the theatre or any designated performance area. Anyone using any kind of mobile device during any part of any performance will be asked to leave.

7.2. Anyone who is found to be behaving in a disruptive manner during any part of a show or performance will be asked to leave the theatre or performance area (see 4.2)

7.3. Any form of unauthorized video or sound recording and or photography is strictly forbidden in any part of the theater or performance area, whilst any performance is taking place. Anyone found doing so will be asked to leave and may have their registration pass confiscated and be excluded from the remainder of the event, no refund will be given.
